Mayor Stanfield stated being noted he had a comment. Mayor Stanfield said on February 28, 2017 the City of LaFollette declared that day Laura Jarnigan day celebrating Black History Month. Mayor Stanfield said Mrs. Jarnigan had sent a thank you card and that he would like to read it aloud.

## ANNOUNCEMENTS

Mayor Stanfield asked if anyone had any announcements. Mr. Jefferies said he had a couple of announcements. Mr. Jefferies asked if March 17<sup>th</sup> would be a good day for the mock City Council meeting at the High School. Mrs. Thompson said she would not be available. Mr. Jefferies said he would try to work out another day with the school. Mr. Jefferies asked the council to call him and let him know who all was going to Nashville on March 20<sup>th</sup> and 21<sup>st</sup> for sure because the rooms were reserved because he needed to get the ones going registered for the conference. Mayor Stanfield asked if there was anything else. Mr. Jefferies replied yes as all the council knows he had been attempting to find an excavator and he had found one in Florida through the military surplus. Mr. Jefferies stated the excavator would be free to the city. Mr. Jefferies said he had spoken to a gentleman regarding the excavator and he said it had been setting for two years. Mr. Jefferies said he had spoken to Mr. Mullens about it. Mr. Jefferies said the gentleman he spoke with said the city might need to look at it before they put in a request for it. Mr. Jefferies said he wanted to see what the pleasure of the council was to let Mr. Mullens and his mechanic look at it and if that was something they would be interesting in doing. Mr. Jefferies said he could go ahead and put in the request for it and he had fourteen days to cancel it out. Mrs. Thompson asked where it was at. Mr. Jefferies replied Florida. Mr. Jefferies said he just needed a direction to go in from the council if they wanted him to ask for it and if they give it to the city let Mr. Mullens go down and look at it. Mr. Jefferies said the city had fourteen days to pick it up or cancel it. Mr. Jefferies said he didn't need a motion he just needed a direction to go with. Mr. Jefferies said it wasn't discussed in the work shop and he had just found it that day. All council agreed for Mr. Jefferies to move forward with it. Mayor Stanfield asked if there was anything else.

There was just that one finding at the Recreation Center and that was it. Mayor Stanfield asked on that one find if they were in the process of correcting it. Mr. Troutman spoke up and said that he had a contract ready that he would give him one to get in compliance. Mayor Stanfield asked if anyone had a motion to approve. **\*Approval to proceed RV Park**

Mayor Stanfield asked what was the pleasure of the council to proceed with the RV Park. Mrs. Thompson replied she had a comment. Mrs. Thompson stated that the council had not fully discussed the cost of the RV Park. Mrs. Thompson stated she knew that Mr. Wilson said it was going to cost around \$7,000 dollars. She was not for taking any additional money out of fund balance to support the RV Park. Mrs. Thompson stated the council had already taken out of Fund Balance \$279,000 dollars in the past seven (7) months. Mrs. Thompson stated the cost factor in its payroll and materials that if they done it in house that they have not explored that avenue that they need to know if it's going to be worth it as far as how much income it's going to bring in verses what it will cost to build it. Mrs. Thompson feels that the council needs to look at it further. Mr.

Wilson stated that they were not tapping into the Fund Balance that if she remembered the workshop he told her it was new money that was coming in that has not been allocated. Mrs. Thompson said that the money was Sales Tax and the money had to go into General Fund which is Fund Balance so it actually has to go into Fund Balance and according to Terry he had to put into there and distribute to all the departments. Mrs. Thompson stated that is actually taking it back out of Fund Balance. Mr. Wilson made the motion to proceed with the RV Park. Mr. Archer made the second. Mayor Stanfield requested roll call which was as follows:

**\*Approval of side walk cut not to exceed 12 feet on North Tennessee Avenue and the corner of the alley way beside the Royal Lunch Room**

Mayor Stanfield stated that they had discussed it in the Workshop. Mayor Stanfield stated that he and Mr. Smith with the Codes Department had met with Mr. Lindsay and discussed the sidewalk with Mr. Lindsay. Mr. Lindsay is willing if the city goes in and cuts and jack hammers the sidewalk up he is willing to pay for the concrete to have his entrance put in at 12 feet wide and the city will come in once they get done with the creek bank they would come in and do the sidewalk and put steel around the fire plug. Mrs. Thompson asked if twelve (12) feet was wide enough. Mr. Lindsay stated that they had talked about 12 or 14 feet but if possible he would like the 14 feet. Mr. Jefferies stated that in the motion it needed to be stated that any work that was done needed to be in ADA compliance. Mr. Jefferies stated that they just needed to make sure that while they were in the process of getting the transition plan together that anything the city would do from here on out they had to make sure it was ADA. Mr. Bolinger stated that he thought putting the steel around the fire hydrant was something that the utility would probably be doing. Mayor Stanfield asked what was the councils pleasure. Mr. Bolinger made the motion. Mrs. Thompson asked if it was for 14 feet correct. Mrs. Thompson made the second. Mayor Stanfield requested roll call which was as follows:

**\*Discuss Bid Procedures**

Mrs. Thompson stated that was something she had put on the agenda. Mrs. Thompson stated she would like to pass out a copy of the city ordinance. Mrs. Thompson stated she understood the city had an ordinance for competitive bidding and that it was required on all purchases for over \$4,000. Mrs. Thompson stated she had informed the city administrator of this and that he stated he did not know that we needed one that he would check with Mr. Sweat and Melissa Ashburn with MTAS. Mrs. Thompson stated that she had spoken with Melissa Ashburn and Mr. Troutman and both of them stated that they needed a bid and Melissa Ashburn had informed her today that she had advised our city administrator to get around this policy that he could check with the city's insurance and Personnel Policy and hire the individuals part time. Mayor Stanfield agreed. Mrs. Thompson stated she did not have a problem with who had been hired she had a problem with the way it was done because they are getting around doing what the city ordinance says they are supposed to do. Reconfiguring the process for competitive bidding is not something she feels the city needs to get into doing when they already have an ordinance in place for this. Mayor Stanfield stated when this thing got started we was just getting our feet wet. Mayor Stanfield stated that Mr. Hoskins donated his track hoe if the city furnished the fuel and paid his operators. Mayor Stanfield stated that if he had a two or three-thousand-dollar piece of equipment he wouldn't put it in the creek bank and take a chance of tearing it up. Mayor Stanfield stated the reason Mr. Hoskins done this is because of our friendship and love for this city. Mrs. Thompson stated she didn't have a problem with Mr. Hoskins doing the work she had a problem with the fact the city administrator wasn't aware that we have a competitive bid ordinance and he didn't follow procedure. Mayor Stanfield stated he does now. Mr. Jefferies stated it is his fault that he realized that on goods we buy that it's a competitive bid under special circumstances. Mr. Jefferies stated that when everything was donated except for labor he wasn't aware that meant competitive bid process and when he spoke with Mrs. Ashburn they immediately stopped on all work until he spoke with her again and she advised him that the city could hire the operators for part time and she advised him to contact Judy Housley with TML, which he did and it brought everything back into compliance. Before starting he didn't know it. Mr. Jefferies stated that it was his fault that he didn't want it to reflect on Mr. Hoskins in any way. Mr. Jefferies stated that Mr. Hoskins is trying to do the city a favor that he didn't think that no one else would donate the machinery that the only thing they had to pay was the operators. Mr. Jefferies stated that it was his fault and his mistake and he apologized that he didn't know it but he knows it now. Mr. Troutman stated that it was an unusual situation donating and he didn't know the answer his self at the time. Mr. Archer stated this project of cutting the sides off of the creek bank letting the water flow through would help with the mosquito control and everything else. Mr. Archer stated none of them,

Ann if you knew it you should have spoken up earlier than you did that you waited until they got the bill in and looked at it and oh that's five thousand dollars. Mrs. Thompson stated she didn't find out how much it was until. Mrs. Thompson said she based it on the fact that he had said they would spend \$25,000. Mr. Archer stated that none of them knew, that he didn't read all the charter and all the ordinance that maybe he should but it has been a really good undertaking project and well needed. Mrs. Thompson stated that she agreed and that she was glad they were doing it. Mrs. Thompson stated that she was excited that she had been wanting it done for years but she was told they couldn't do it. Mayor Stanfield stated that's correct. Mr. Archer states that it took a lot of effort from Mr. Jefferies and everyone that had worked on it. All of them done the line that had agreed to let them do it from TVA on down. Mayor stated that the merchants was happy with it and he was tickled with it and asked to move on.

### **\*Discuss Committees and Council Members**

Mrs. Thompson stated it was also her item on the agenda and she would like to clear the air. Mrs. Thompson stated after all the insults and confusion voiced towards her by a select few she has no desire to serve on the ATV Festival Committee in any compacity. Mrs. Thompson stated that she found it very sad that Mr. Jefferies knows for a fact that she was the one person who helped him get the festival started while he was still police chief and he will not admit it. Mrs. Thompson was accused of not turning over the paperwork to the committee. Mrs. Thompson stated that she had three text messages from Mr. Jefferies stating that he would come by and pick up the paperwork, which he did not. Furthermore, every check, form, application that she picked up and received was taken directly to Donna she made copies of everything for her records. Mrs. Thompson stated that she kept copies for her records and Mr. Sweat kept all the financial records with the exception of a few that she received afterwards nothing was said about any of that. Prior to February workshop Mr. Jefferies had said that he would be happy to have her back on the ATV Festival Committee and then a few days later he called her and told her he would prefer council to vote on it. During the workshop, Mayor Stanfield said it once and Mr. Jefferies said it twice that any council member can serve on any committee. During the workshop discussion Mr. Jefferies stated he had no problem with her being on any committee. During this discussion, Mr. Jefferies then agreed with Mr. Wilson's statement of letting the festival committee decide. Mrs. Thompson stated she was under the impression that any council member could be on any committee, so apparently, she doesn't know or neither does the City Administrator. Mrs. Thompson stated the council needed to make a decision, can council members serve on committees, does the city administrator decide who does it, does the council decide, or does the committee vote for its own members or who initially establishes the committee. Mayor Stanfield stated that if your elected by the people you have the right to be on any committee in the city so choses. Mayor Stanfield stated if you wanted to be on it. Mrs. Thompson stated that she had no desire to be on it, that she just wanted it to

be made clear that she had a right to be on it or any committee within the city. Mayor Stanfield asked if there was any more comments.

**\*Discuss accusations made by Vice Mayor Bolinger to Mrs. Thompson**

Mayor Stanfield asked Mrs. Thompson if that was her. Mrs. Thompson replied yes, it is. Mrs. Thompson stated first of all that Mr. Jefferies knew that she had no intention of taking over the ATV Festival. Mrs. Thompson stated that she and Mr. Jefferies spoke several times of her desire to take over the vendors and the sponsors as she had done in the past during the first and second part of the festival. Mrs. Thompson stated that this part of the conversation was between Mr. Jefferies and her, and that she did not know where Mr. Bolinger had gotten his information. Mrs. Thompson stated that during the February 27<sup>th</sup> city council workshop a discussion was underway as part of the agenda regarding the ATV Festival Committee and herself. Mrs. Thompson stated that council member Joe Bolinger started attacking her integrity, that Mr. Bolinger stated that she got on a classified computer and printed off a personal letter, and she distributed the letter and threatened people. Mrs. Thompson stated that she was shocked that Mr. Bolinger would publicly slander her name with his accusations, as a result of this purposely and maliciously bringing up the subject irrelevant to the discussion at hand. Mrs. Thompson stated that this slander has further been publicized on the internet, radio, and newspaper causing her unwanted stress and embarrassment. Mrs. Thompson also stated that she was further amazed that Mr. Bolinger would bring up a nine-month-old past subject that directly pertains to a relative of his and a city administrator failure to act upon that information that was included within that letter. Mrs. Thompson stated that Mr. Bolinger had said you assigned Mr. Jefferies to investigate the letter. Mrs. Thompson asked Mr. Troutman if he had done that. Mr. Troutman replied to her if he had assigned Mr. Jefferies to do that. Mrs. Thompson replied yes. Mr. Troutman replied absolutely. Mrs. Thompson asked if he received results from that letter. Mr. Troutman asked if she was talking about results from the letter and stated he had received them verbally. Mrs. Thompson asked Mr. Troutman why Mr. Jefferies was assigned that task. Mr. Troutman stated that Mr. Jefferies was the city administrator and that was his job. Mrs. Thompson stated that it was addressed to him and his failure to act upon the letter. Mr. Troutman stated that any employee dispute was his responsibility to look into especially an allegation initially with employees, that was absolutely his job. Mrs. Thompson stated that according to Mr. Jefferies he didn't do a written report. Mrs. Thompson stated that she was there to publicly say that she did not access a public computer, she did not distribute a letter. Mr. Bolinger asked who carried the letter to Mr. Jefferies. Mrs. Thompson stated no one to her knowledge, that she did not give it to him. Mr. Bolinger asked Mrs. Thompson if she did or did not go to Mr. Jefferies office and tell him if he didn't stop the investigation it would cause a problem. Mrs. Thompson stated that she did not tell him to stop the investigation. Mr. Nick Thompson from the audience told Mrs. Thompson to not answer those questions. Mr. Thompson stated the

only question she could ask was why Mr. Bolinger was the only council member at the time that knew something about it. Mrs. Thompson stated that according to Hansford Hatmaker and according to Bob Fannon no one else knew he was doing an investigation. Mayor Stanfield stated to let him solve this right now. Mr. Bolinger asked to let him comment please. Mr. Bolinger stated that she said he come out and accused her, he stated he did not accuse her, and he didn't know about the letter at the time. Mr. Bolinger stated that he knew about the letter later after he started after she had asked him about serving on the ATV Committee after our last meeting. Mr. Bolinger stated that he went around and talked to people and that's when he found out all that stuff. Mr. Bolinger stated that it didn't matter what was in the letter that Mrs. Thompson told in the first workshop that she got it off the printer, a few minutes later she said that two of the employees gave it to her. Mr. Bolinger asked which was it. Mrs. Thompson stated it didn't matter how she got it she was just telling him she did not take it off the computer. Mrs. Thompson stated that she did not print it or access the computer. Mr. Bolinger asked Mrs. Thompson why she told Mr. Jefferies that. Mrs. Thompson stated she wasn't discussing it any further, she just needed to make it clear. Mayor Stanfield stated to Mr. Bolinger that he was going to end it right now, that Mr. Archer or Mr. Wilson did not know anything about it, and he didn't really give a flying crap about it either so as far as he was concerned right now it's dead and to move on.


